What data does it concern?

Which data specifically is not processed?

We do not register or store data such as religion or belief, race, political opinion, membership of a trade union or political party.

For what purpose do we process data?

Muller Dordrecht processes your personal data for the following purposes:

- Agreement: The processing is necessary for the performance of an agreement, or to take measures before the conclusion of an agreement.
- Legal obligation: The processing is necessary to comply with a legal obligation.
- Consent: The processing for which permission has been granted by the person concerned.

Who do we share your data with?

In the context of the above mentioned objectives, it is necessary that we share certain data with external parties such as the salary processor for your salary payment. In addition, we share absenteeism information with Anders Verzuimmanagement. We also share information with the tax authorities from the legal obligation. In addition, if necessary, we share information with customers and clients, such as your certificates.
